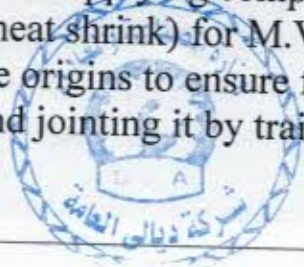

Required documents

1. 2. Rehabilitating the production halls which exist in Diala Company site and providing it with necessary requisites (rehabilitating floors, walls and ceiling- electrical works – mechanical works – cranes – forklifts – electrical generator – air conditioning system – vocational safety equipments – any additional requisites serve the production process) to match installing the production lines and the machines to suit the project requirements and workload .

Construct and supplying complete line to individualize and assemble cable kitting operation (heat shrink) for M.V cables in production capacity 20000 pieces/year from reliable origins to ensure fulfilling required production capacity, positional executing and jointing it by training our company staffs on these works.



4. Supplying raw materials and semi-finished parts and all production requisites from reliable international origins. Also providing us with technical specification for the raw materials consume averages , damage rates , the technology process , products operation and final test works
